## Rental Agreement and Liability Waiver

It is the responsibility of the person or organization renting this bounce house equipment to ensure that all possible precautions are taken to avoid injury to people or damage to the Bounce house. Please ensure that the following Safety Instructions are followed:

- 1. No food, drink or chewing gum on or around the bounce house.
- 2. Shoes, glasses, jewelry, and badges MUST be removed before using the bounce house.
- 3. No face paints, party poppers, colored streamers or silly string to be used either on or near the bounce house.
- 4. NO barbegues or smoke around the bounce house.
- 5. Climbing, hanging or sitting on walls of bounce house
- 6. A responsible adult must supervise the bounce at all times.
- 7. Always ensure that the bounce house is not overcrowded and limit numbers according to the age and size of children.
- 8. No pets, toys or sharp instruments on the bounce house at anytime.
- 9. Do not allow anyone to bounce on the front safety step as this is dangerous.
- 10. Please ensure that children are not attempting any acrobatics and are clothed appropriately.
- 11. Please never try to inflate or deflate the bounce house.
- 12. In the event that the blower stops working, please ensure all users get off the inflatable immediately and calmly and call 407-728-3030 immediately. We will be able to troubleshoot over the phone or come out to resolve the issue.

*Always remember do not let children play on the bounce house without adult supervision	. Adult
supervision is necessary to enforce the bounce house rules for safe operation.
